

Product Information for Auction No. 2/2022

Erdgasspeicher Peissen GmbH (EPG) envisages to carry out an auction for certain Storage Capacities via the electronic Marketing Platform PRISMA on 01.06.2022 from 10:00 until 11:00 CET. The auction will be based on the following documents, which are/will be available on EPG's website:

1. Storage Service Agreement, version 9.4
2. Annex 1 to the Storage Service Agreement: General Terms & Conditions of Access version 4.0

In order to participate in this auction, the bidder should be registered as an Authorized Storage Customer at EPG latest by 31.05.2022 and in addition as a shipper at PRISMA European Capacity Platform GmbH subject to the applicable general terms and conditions of the provider of the Electronic Marketing Platform PRISMA (as displayed on its Website).

For technical reasons the EPG standard bundle definition which is in m³ ("EPG Standard Bundle" as further clarified below in Product Details) deviates from the respective bundle definition of PRISMA which is expressed in kWh (as further clarified below in Product Details). This requires particular caution of the Storage Prospect throughout the bidding process of the Auction as further described below.



1. Product Details:

The storage capacities are available as of 15.06.2022 for the remainder of the Storage Year 2022 until 01.04.2023.

* The conversion factor of 11.215 kWh/m³ applies only for clarification purposes of the product definition in accordance with PRISMA requirements in order to make the potential bids throughout the Auction in line with PRISMA requirements. The Storage Services Agreement will be concluded according to the bundle definition of EPG in m³ (EPG Bundled Product) in accordance with Annex 3 Storage Specification, version 9.0.

According to the EPG bundle definition the Storage Capacities offered in this Auction No.2/2022 consist of 33 EPG standard Bundled Products. The related Storage Capacities according to EPG's standard Bundled Product definition may be booked in total or separately in 33 EPG Bundled Products (Product 1).

Based on successful bids throughout the Auction in accordance with the above described requirements the Storage Customer will conclude a Storage Services Agreement based on the EPG bundle definition and the related product definition in accordance with EPG's Storage Specification (Annex 3) based on the above described conversion of the bids for product 1 according the PRISMA-definition into the respective EPG standard Bundled Products depending on potentially successful bids.

In case the Auction will not lead to an allocation to any bidder EPG reserves the right to offer the previously auctioned storage capacities until further notice at the same conditions to any interested potential storage customer who may issue a storage request directly to EPG.

2. Pricing:

Throughout this Auction a storage prospect will have to observe the following minimum bid prices for the minimum Fixed Storage Fee:

Based on successful bids throughout the Auction in accordance with the above described requirements respecting the minimum bid price according to PRISMA conditions the Storage Customer will conclude a Storage Services Agreement

based on the EPG conditions in accordance with EPG's Storage Specification (Annex 3) based on the above described conversion of the bids based on PRISMA conditions into the respective Fixed Storage Fee based on EPG conditions depending on the potentially successful actual bid at PRISMA conditions (at minimum bid price or above) and the conversion into a Fixed Storage Fee at EPG conditions.

For clarity sake: the Storage Customer shall pay in addition to the Fixed Storage Fee a Variable Storage Fee in EUR/m³ for Injection and Withdrawal in accordance with the related provisions of the Storage Services Agreement (subject to potential adjustments in line with the Storage Services Agreement) and published on EPG's website as per the "General Determination Procedure Variable Storage Fee".
